The Stakeholders Relationship Committee (SRC) of Board of Directors of the Company has *vide* Circular Resolution dated August 20, 2024 approved the allotment of 2,14,055 Equity Shares of Rs.5/- each on August 21, 2024 at 01:12 PM (IST) to the option grantees who have exercised their options granted under the ESOP Schemes detailed hereunder:
